

Conference Evaluation




Overall satisfaction with the conference.




Overall satisfaction with the exhibits area.




Overall satisfaction with the format of the conference (i.e. morning sessions, breaks, lunch, and afternoon sessions/breakouts).




Overall satisfaction with the reception and breaks.




Overall satisfaction with the facilities.
