

Proposal for an Intellectual Property Guide in the Tempus IP Med Project

The proposal is that the IP guide envisioned in the project be implemented as a Wiki, which allows the partners to draw on invited persons within their network to further contribute and to maintain a dynamically updated. The Wiki will be moderated by the Maastricht partners, and manage the appropriateness of the entries, with quality control being a joint element of the group Wiki review process and the moderator.

The primary content of the international, multilateral, regional, and bilateral elements of the Wiki will largely come from Maastricht and its partners.

I. Structure and Content of the Wiki

The Wiki will be organized by country, encompassing every country in the region. Importantly, the aim of the guide will be to identify and elaborate differences between the subject countries which will form the basis for debates and discussions about the merits of harmonization versus differentiation.

Under each country there will be a set of subject areas with subheading addressing key sources. The aim will be to provide links and also to provide a rolling dynamic set of annotations to legislation, policy, and cases.

Under the leading cases, there will be a short summary of the case, its ruling and its reasoning.
